The memory of Minoan Crete is preserved in the names of Minos, Rhadamanthys, and Ariadne; very likely in the names of Idomeneus' opponents Phaistos,

son of Boros, and Asios, son of Hyrtakos, may be found reference to the Achaean conquests in Crete.
