The available evidence indicates decisively that Homer, in describing
the burials of his heroes and warriors had in mind the burial customs
of the Mycenaean Age. These customs he knew from the traditional
oral poetry from which he drew his information regarding the Trojan
War. The assumption that Homer used his contemporary customs is
proved untenable. The evidence indicates that a cult of the dead did
not exist in Mycenaean times. A sacred character should not be
attributed to the graves of the Mycenaean period.
